Message from the Editor:

Greetings from everyone at AICE.

Much has been written about the 2017 AICE Symposium in Minneapolis. Earlier this month, the event brought together professional evaluators, senior representatives from AACRAO and many university representatives for an engaging event culminating in new insights on best practices with three-year degrees from across the globe. I am grateful to my colleagues on the planning committee and to all attendees for this professional development opportunity, and I am already looking forward to planning the next AICE Symposium for 2018.

In a few short weeks, I will be traveling to the NAFSA annual conference in Los Angeles. Coincidentally, this year marks my tenth year in the field of credential evaluation, and I'll be returning to Los Angeles where I attended my first NAFSA Annual Conference in 2009. Consequently, I'd like to reflect how the field has changed in the ten years I have been in it.

Technology affects most professions, and the last ten years included significant changes in how business, politics, education, and social interaction uses technology. Of note, when I first started in this field, the electronic transfer of student data, credentials, and international communication was still in its early stages. Now, it is becoming the norm. As credential evaluators, embarking on the frontier of electronic international credential mobility, we are faced with new challenges of determining authenticity, verifying sources and combating new types of fraud and forgery. The easy response is to exclude electronic data, and maintain the tried and true methodology of relying on official documents received directly from the issuing institution via post. In the digital age, this is not only cumbersome, but is no longer sustainable. As an international educator, a credential evaluator, and an AICE Endorsed Member, I embrace the challenge of expediting student data transfer through technology, but I remain vigilant in maintaining authenticity and integrity in the process.

On April 27, 2017 in Melbourne, Australia, AICE became a signatory to the Groningen Declaration. The summarized goal of the Groningen Declaration is to "make Digital Student Data Portability happen" in an ethical, sustainable, yet accessible manner. I look forward to working

within the framework of the declaration to enhance the advancement of international education and the profession of credential evaluation through technology.
