Message from the Editor:

Greetings from everyone at AICE.

Having completed a second successful Symposium, AICE members and affiliates remain busy investigating interesting credential quandaries, overcoming challenges, and promoting accurate recognition of international educational credentials within the US education system. The trained experts who do this work follow an established set of standards, published on the AICE website, regularly reviewed, and universally subscribed to by Endorsed Member evaluation services. As full-time professionals, we are abreast of all current developments in comparative international education. However, we can still be challenged when facing credentials earned in older education systems, even from countries which no longer exist.

This challenge presented itself at this month's AICE Credential Forum, where Endorsed Members and Affiliates discussed Yugoslavian credentials from the 1980s. To summarize, the post-secondary education system in Yugoslavia consisted of first-level university degrees (Diploma), second-level university degrees (Specijalist/Magister) and third-level doctoral (Doktor) programs. When attempting to describe these credentials within the context of the Bologna Process, the first-level university degrees can erroneously be considered equivalent to Master's degrees, because their duration is longer than the current first-university three-year degrees. However, Master's degrees are second-level degrees, and this equivalence should be reserved for other second-level university programs when they exist, notably the second-level Specijalist/Magister programs from Yugoslavia.

The learning outcome of this discussion proves the importance of using resources and placement recommendations from the era when the credentials were earned. The Yugoslavian discussion was fueled by research published in a 1990 Pier Workshop Report. It is difficult to find mention of the Yugoslavian education system on current websites. In summary, a well-stocked library of resources spanning different decades is essential for accurate credential evaluation.
